### SPECIAL ARRANGEMENTS:

The attached permit must be displayed on the right side of the front windshield whenever the vehicle is on the Parkway or on Park property. Unless noted above, buses coming to the New Jersey Section of the park must enter via Hudson Terrace/River Road or Alpine Approach Road, proceed along Henry Hudson Drive, and exit by one of these routes.

Permits for field trips and outings, for groups coming to the park or traveling on the Parkway, must be secured by the school or organization responsible for the students or campers. Groups over 25 people, coming to the park for an event, must apply for a General Activity Permit.

Possession of this permit does not guarantee entry or re-entry to the park when an area is closed or filled to capacity. Park roads and drives may be closed to all traffic due to weather conditions, thereby canceling this permit. If in doubt, the person-in-charge should contact the Park Police at 201-768-6001. Rain dates should be considered.

Complete permit applications, including fees and supporting documentation, must be received 48 hours in advance of event to allow sufficient time for permit to be processed and distributed.

This permit is not valid until it has been signed by both parties and cannot be sold, transferred or reissued. Please read the entire contract, sign it and return it to the Park Commission along with the required payment and a copy of the permittee's driver's license. An executed copy of the contract will be mailed to you along with a receipt for payment.

This permit is granted with the understanding that the person(s) or organization listed above will comply with the rules and regulations of the Palisades Interstate Park Commission and the specific conditions set forth above. Failure to do so will result in revocation of this contract and denial of future requests.
